

## Advancing First Class Pre-K in Alabama: Fact Sheet: Expanding Access to First Class Pre-K

### Introduction

This fact sheet summarizes key findings about Pre-K access from the Advancing First Class Pre-K in Alabama project. Alabama's nationally recognized Pre-K program provides high-quality early education. However, only 41% of the state's four-year-olds are currently enrolled, leaving thousands of children without access to this critical opportunity.

### Key Findings

- **Significant Demand:** 5,200 Alabama four-year-olds are on First Class Pre-K waiting lists.
- **Uneven Access:** Enrollment rates vary dramatically by county, from 19% to 95%. Metropolitan areas and counties with growing populations often have lower enrollment rates due to high demand and limited classroom space.
- **Targeted Expansion Needed:** To maximize impact, Pre-K expansion should prioritize counties with high waitlists and low enrollment rates.

A strategic investment to expand First Class Pre-K will yield significant returns:

- **Addressing Immediate Need:** Targeting the 20 high-priority counties will directly address some of the unmet demand for First Class Pre-K.
- **Boosting Statewide Access:** Resolving 50% of the waitlist in these 20 priority counties would require an additional 115 classrooms, resulting in a 3.5 percentage point increase in the statewide enrollment rate.
- **Laying the Foundation for Future Success:** High-quality Pre-K has been shown to improve children's academic achievement, social-emotional development, and long-term life outcomes.

Without increased investment:

- Thousands of Alabama children and families will continue to miss out on the benefits of high-quality Pre-K.
- The opportunity gap will persist, limiting opportunities for children from disadvantaged backgrounds.
- Alabama will fall further behind other states in providing universal access to early education.

## Recommendations

To continue expanding access to First Class Pre-K while maintaining high quality, we recommend:

- Allocating additional funding to add new First Class Pre-K program in the next legislative cycle – a critical step towards achieving universal access.
- Supporting a Strategic, Two-Phased Approach:
  - **Phase 1: Achieve 50% Access Statewide:** Add about 250 classrooms, focused on high-priority counties, and increase classroom grant amounts to account for rising costs. This would directly address waitlists and increase the statewide enrollment rate by approximately nine percentage points (41% to 50%). This phase is achievable within the program structure and builds on existing infrastructure.
  - **Phase 2: Expand Beyond 50% with a Transformative Investment:** Reaching greater than 50% access will necessitate a significantly larger financial commitment.

Expansion beyond 50% is likely to require:

- **Addressing Space Concerns:** Building new facilities and/or renovating existing spaces to accommodate Pre-K classrooms.
- **Fully Funding Teacher Salaries:** Ensuring competitive compensation to attract and retain qualified educators.
- **Expanding Support Services:** Providing options for transportation and after-school care to meet the needs of working families.
- **Strengthening the Early Childhood Workforce:** Expanding pathways and financial incentives for early educators to pursue credentials.
- **The Bottom Line:** A substantial, targeted investment in First Class Pre-K is essential to increase access, ensure high-quality learning opportunities for all Alabama children, and build a stronger future for our state.
